MIKE JONES ADMINISTERED THE OATH OF OFFICE TO COMMISSIONER-AT-LARGE TO MAYOR KOLBY ARNOLD.

OUTGOING MAYOR KAREN HAWKINS STEPPED DOWN AND WELCOMED MAYOR KOLBY ARNOLD TO HIS SEAT AT THE COUNCIL TABLE.

MIKE JONES ADMINISTERED THE OATH OF OFFICE TO CITY TREASURER TO MELISSA COLVIN.

MIKE JONES THEN MADE HIS RECOMMENDATIONS FOR THE APPOINTMENT OF COMMISSIONERS FOR WARD 1 AND WARD 3, AS THESE POSITIONS WERE NOT FILLED DURING THE APRIL 6TH ELECTION. BOTH POSITIONS WOULD REQUIRE AN APPOINTMENT SELECTION. HIS FIRST RECOMMENDATION WAS FOR CHRIS PADILLA AS COMMISSIONER FOR WARD 1. HIS NEXT RECOMMENDATION WAS FOR LUKE HAGUE AS COMMISSIONER WARD 3.

COUNCIL THEN DISCUSSED AND CONSIDERED THE CITY MANAGER'S RECOMMENDATION FOR COMMISSIONER WARDS 1 AND 3.
