 - ON JUNE 18TH, 2021, THE FEDERAL GOVERNMENT ADOPTED A NEW FEDERAL HOLIDAY, JUNETEENTH. JUNETEENTH IS TO BE CELEBRATED ON JUNE 19. THIS HOLIDAY WILL BE INCLUDED TO THE PROPOSAL TO COUNCIL MEMBERS IN DECEMBER WHEN 2022 HOLIDAY CALENDAR SCHEDULE IS CONSIDERED FOR DISCUSSION.
