- OVER NEW YEAR'S WEEKEND ONE WATER WELL FROZE, BUT WE WERE ABLE TO UTILIZE OTHER WELLS TO PROVIDE ADEQUATE WATER FOR OUR CUSTOMERS. ALL WELLS ARE CURRENTLY WORKING PROPERLY.

 DUE TO THE FREEZING TEMPERATURES ON THE 7TH, THIS LEAK WAS NOT REPAIRED UNTIL SATURDAY, JANUARY 8TH.
- ON 1/10/22 CREWS WORKED TO REPAIR THE MAIN VALUE ON THE SOUTH WATER TOWER. A TEMPORARY REPAIR HAS BEEN CONDUCTED. THE VALVE WILL BE REPLACED AS SOON AS POSSIBLE.
